4. Staff Profile – Vince Massaro/Kim Beaver

Vince Massaro introduced Kim Beaver, Grants Manager for SPC responsible for fiscal reporting and county aspects of all FDA administration grants. Prior to joining SPC, Kim was a Research County Analyst at Duquesne University. Prior to that Kim worked at the Port Authority of Allegheny County for 13 years holding the position of Manager of Grants Accounting for 8 years.

Kim Beaver described his responsibilities at SPC, which include analysis, administration, and monitoring of SPC's various federal formula transportation funds and state assisted grants to make sure that we comply with all of the applicable federal and state regulations.

My primary focus at SPC has been the FTA JARC and NFI formula grant programs. There are currently 8 JARC projects and 4 NFI projects. JARC's primary goal is to improve the access to transportation services, employment, employment related activities for eligible recipients and lower income individuals. Goals of the New Freedom Formula Grant Program are to provide additional

tools to overcome existing barriers facing American's With Disabilities seeking integration to the workforce and full participation in society.

5. <u>Financial Report – Vince Massaro</u>

Mr. Massaro reported that the financial report reflects the fiscal period July 1, 2010 to January 31, 2011, 58% of the fiscal year completed. This report reflects the operations of the Corporation, the Commission, and the Regional Enterprise Tower. Today, the Corporation Board of Directors and the Commission Executive Committee approved and adopted the revised budget.

Total project revenues to date are 59.64% recognized compared to a revised budget of \$14.7M. Current project revenues include UPWP projects and any carryover projects from prior fiscal year, and the operations of the Regional Enterprise Tower. It also includes projects for the Enterprise Development Program.

All federal and state grant agreements have been executed and are in place. Revenues relating to the operations of the building are budgeted at \$3.8M through the end of June. The current tenant occupancy is at 65%.

At the end of December, the Alcoa Endowment at the Pittsburgh Foundation remained below \$5M and unavailable to the building for any purpose. RET operation expenditures including depreciation and amortization expense are \$3.4M versus the revised budget of \$5.4M or 63% of the budget expended through the reporting period. Total project expenditures reported and encumbered to date are \$8.7M versus a revised annual budget of \$14M or 59.67% of the budget expended and encumbered to date.

Department of Transportation, and the Pennsylvania Department of Transportation relating to the 2011-2012 Unified Planning Work Program and pursuant to application requests.
