Chuck DiPietro called the meeting to order at 10:00 a.m. Chuck announced that the meeting is being recorded for minute taking purposes only.

**1. Action on September 12<sup>th</sup> Minutes – Attachment A**

Motion was made by Art Cappella and second by Jeff Leithauser to accept the September meeting minutes with no revisions. TTC approved.

**2. Public Comment**

There was no public comment.

**3. FHWA/PennDOT Central Office Reports**

a. State Updates

Kevin McCullough and Chuck DiPietro provided status reports on the following items:

MAP-21 Pending TIP Adjustments – Central Office Programming Center has completed funding code changes for the 2013-2016 TIP in FFY's 2014, 2015 and 2016 to reflect the changes from SAFETEA-LU to MAP-21. This effort will align the current TIP with MAP-21, and serve as a basis for the 2015 TIP update.

STIP REVISED schedule – As mentioned last month, statewide financial guidance on the distribution of federal and state transportation monies have not yet been agreed upon. Subsequently, submittal of the draft TIP to Central Office expected to be delayed by approximately 3 months. Draft TIP typically would be submitted to Central Office at the end of December.

State Transportation Bill – Dan Cessna highlighted a positive conference call he participated in with PA Transportation Secretary Schoch. He noted that prevailing wage is a key new element affecting closure on a new bill. As part of any eventual package, the Republican majority in the state House wants Pennsylvania's prevailing wage law, which requires the use of a union pay scale on public projects that cost more than \$25,000 be raised to \$100,000. In addition, they would like the definition of maintenance to include activities such as: resurfacing, base repairs, and microsurfacing. These items should not be classified as construction items, being subjected to prevailing wages. Both these changes would benefit rural local governments, who are struggling to afford transportation infrastructure related costs.

October 30-November 1 Fall Planning Partners – At the statewide meeting in Mechanicsburg, the 2015 TIP financial guidance, general and procedural guidance, and TIP adoption schedule are expected to be finalized. SPC staff will present this anticipated TIP update closure, along with additional information from the Fall Planning Partners meeting, to the TTC at the November 14<sup>th</sup> meeting.

b. Federal Updates

Chuck DiPietro and Kevin McCullough provided updates on the following items:

Highway Trust Fund – The current Highway Trust Fund projections continue unstable. Starting in federal fiscal year 2015, the trust fund will have insufficient resources to meet all of its obligations, resulting in steadily accumulating shortfalls. Historically SPC’s obligation limitation is approximately 87%. Come 2015, if no action is taken, the limitation level may drop to under 50%, severely crippling the delivery of region’s transportation program.

MAP-21 Compliance – MAP-21 places greater emphasis on the highest transportation system (Interstate, enhanced NHS); a large percentage of overall transportation funding is being directed towards it. This is a challenge for areas of the state that do not have many miles of the higher system. There is dramatic reduction in funding for the lower system, so it will be a severe challenge for them to maintain roads and bridges on the STP network.

**4. Action on Amendments & Modifications to 2013-2016 TIP**

a. District 10-0 – Attachment A

Dave Cook of PennDOT District 10-0 reviewed the requested administrative actions to the current TIP. Jeff Raykes’s motion was second by Jeff Leithauser, and TTC approved the administrative actions requiring TTC approval as presented.

b. District 11-0 – Attachment B

Rob Miskanic of PennDOT District 11-0 reviewed the requested amendment and administrative actions to the current TIP, including the Sports and Exhibition Authority’s I-579 “Cap” project. TTC discussed SEA’s request to add the project’s PE phase to the TIP in 2014 with deobligated TCSP funds from the project’s Study phase.

SPC staff highlighted the following concerns:

- o Estimated \$30 M project cost exceeds the threshold in the established SPC TIP Modification Procedures that requires the action be processed as a Major TIP Amendment.
- o It is not typical to add a project to the TIP (excluding Study phases) unless full commitment of funds to complete the entire project is demonstrated. At this time, only PE funds are committed. Subsequent phases are not identified on the TIP or Long Range Plan, and confirmed funding sources for the project cannot be fiscally demonstrated. If the project does not advance past PE, the SEA would be responsible for paying back the TCSB funds expended. PennDOT clarified that the SEA fully understands the payback possibility.

TTC concluded that any future request to further program phases beyond PE on the I-579 “Cap” project would be processed as a Major TIP Amendment, which requires a 30-day public comment period, review of financial plan, and commission approval.

Art Cappella’s motion was second by Anne Ogoreuc , and TTC approved the amendment and

administrative actions requiring TTC approval; with the understanding that a future request to add subsequent phases to the I-579 “Cap” project would be processed as a Major TIP Amendment.

c. District 12-0 – Attachment C

Angela Saunders of PennDOT District 12-0 highlighted a few administration actions for informational purposes only. District 12-0 had no amendment requests or administrative actions requiring TTC approval.

**6. Advance 2015-2018 TIP Update**

a. Round 3 WG Meetings: Summary/Follow-ups

Third round of Highway TIP Development Work Group sessions have concluded. The Work Groups discussed: MAP-21 TIP compliance and adjustments, Federal Aid Highway Networks and the shifting of funds to the Enhanced National Highway System, 2013 TIP carryover projects, and 2015 new candidate projects. Work Groups are to review 2013 TIP carryover projects and potential financial implications, as presented at third round of work sessions.

b. October 8<sup>th</sup> Financial Guidance Work Group

The Statewide Financial Guidance Work Group met on October 8<sup>th</sup>. Items discussed included: Possible PennDOT Central Office management of the enhanced National Highway System (similar to PennDOT’s Current Management of Interstate Program), Map-21 TIP compliance and TIP adjustments, Highway program formulas for financial guidance, Revised TIP Schedule, and upcoming Fall Statewide Planning Partners meeting.

c. October 16<sup>th</sup> CMAQ Evaluation Committee

A meeting of the CMAQ Evaluation Committee (CEC) was held on October 16<sup>th</sup> at SPC. Committee members are evaluating the candidate projects against ten scoring factors.

The CEC's questions and requests for additional information about individual projects have been forwarded to project sponsors. The air quality benefit of each candidate project is being modeled by SPC staff, for review by the CEC at its November 6<sup>th</sup> meeting.
