The seventy-third meeting of the Southwestern Pennsylvania Commission was called to order by Chairman Dan Onorato.

Dr. Hassinger mentioned that today's meeting is a live interactive Web Conference with a second site for SPC Commissioners attending a CCAP Board Meeting in Harrisburg.

1. Action on Minutes of the December 15th Meeting

A motion was made to approve the minutes of the December 15, 2008 meeting of the Southwestern Pennsylvania Commission by Commissioner Kirkpatrick which was seconded by Commissioner Ruddock. The affirmative vote to approve the minutes was unanimous.

2. Public Comment – None

3. Financial Report

Mr. Massaro said the financial report reflects the operations of the Corporation, the Commission, and the Regional Enterprise Tower and is for the fiscal period July 1, 2008 through December 31, 2008. He said that 50% of the year is completed. The report includes the revised annual budget numbers. The revised budget was presented at the Board and Executive Committee

meeting earlier today which was reviewed and adopted. This report compares the actual to date and the actual encumbrances to date against the revised budget.

Total Project Related Revenues recognized and recorded to date including encumbrances are \$4,819,125 vs. the revised annual budget of \$9,323,838 or 51.69% of the budget expended and recognized. Those items relate to the current fiscal year UPWP program for 08-09. Mr. Massaro said that with the revised budget under the UPWP program there were three projects that were originally budgeted to be expended by June 30, 2009. We received authorization from PennDOT to extend those projects through June 30, 2010. These projects are the Regional Traffic Signal Design and Service Program, the Truck Parking Study, and also the West Busway TOD Study.

Carryover Project Related Revenues, which are the carryover projects from FY07-08, recognized and recorded revenues to date including encumbrances are \$147,688 vs. the annual budget of \$198,154 or 74.53% of the budget recognized for the reporting period.

Total Project Revenues – revised annual budget of \$9,521,992, encumbrance \$4,966,813 or 52.16%. Revenues for operations of the Regional Enterprise Tower to date are \$2,238,590 in rents recorded vs. annual budget of \$5,415,686 or 41.34%. Mr. Massaro mentioned that on the building side, we received our December numbers late and didn't have time to get them into this report, so actually these numbers are through November.

Mr. Massaro said that for the Endowment, originally we anticipated zero dollars, but under the revised budget, \$224,764 did become available for drawdown, and at the December 15th Property Committee meeting the Committee approved drawing down those funds and just today we received a check from The Pittsburgh Foundation for that dollar amount.

Total Revenues are \$15,162,442 revised budget and encumbrance to date is \$7,207,752 or 47.54% of the budget.

Mr. Massaro said regarding expenditures, you can see we have sufficient revenues covering expenditures. We show the operations of the Regional Enterprise Tower expenditures and depreciation is included for total expenditures of \$7,482,272 up against a revised budget of \$15,863,381 or 47.17%.

A motion was made to approve the financial report by Commissioner Camp which was seconded by Commissioner Fink. The affirmative vote to approve the financial report was unanimous.

4. Action on Resolutions 1-09 and 2-09 to Amend the 2035 Transportation and Development Plan, 2009-2012 TIP and Accompanying Air Quality Conformity Determination for Brighton Road Extension – a Sports and Exhibition Authority Project

Mr. DiPietro reported that we have been asked to advance the Brighton Road Extension project that is currently on Stage 2 of the 2035 Long Range Plan to the Plan's first stage, the current TIP. The Brighton Road Extension project on the North Side is scheduled for construction to begin in the spring by the Sports and Exhibition Authority right next to the planned new sports and entertainment complex. The total cost is \$1.8M of which \$.73M is covered by a federal earmark and \$1.07M is covered by the Sports and Exhibition Authority. The project was out for Public Comment from December 17, 2008 through January 21, 2009. Today's agenda packet includes

responses to the comments received and a fact sheet on the project. Mr. DiPietro also reported that the Transportation Technical Committee recommends Commission approval of this request today.

In response to a question from Mr. Silvestri, Mr. DiPietro responded that the scope of work includes construction of a new connector road and related streetscape improvements between North Shore Drive and General Robinson, adjacent to the new planned Entertainment Complex and Amphitheater.

Mr. Miller asked for clarification regarding the accompanying air quality conformity request for action. Mr. DiPietro responded that EPA's Transportation Conformity Rule requires a new bending of conformity by the MPO prior to action to adopt or amend LRP/TIP for projects classified as "non-exempt" like the Brighton Road Extension Project. This required air quality conformity analysis was completed, demonstrates conformance with the Clean Air Act, and was also part of the public review and comment period.

Mr. Miller also pointed to the public comment submitted by Mr. Jerrold Green, a North Side resident: "I would like to propose that the new roadway and its intersections be reviewed with respect to how they will accommodate, and indeed, attract bicycle and pedestrian traffic." Mr. DiPietro responded that these concerns have been forwarded to the Sports and Exhibition Authority and to the City of Pittsburgh for their consideration in the final design process.

Mr. Daughenbaugh moved:

WHEREAS, the federal Clean Air Act authorizes the Environmental Protection Agency (EPA) to establish National Ambient Air Quality Standards (NAAQS), to define the boundaries of areas not in attainment of the Standards, and to establish criteria and procedures for attaining and maintaining the Standards; and

WHEREAS, the Southwestern Pennsylvania Commission (SPC), as the MPO for the Pittsburgh Transportation Management Area, is responsible under Section 134 of Title 23, U.S.C. and Section 5303 of Title 49, U.S.C. for carrying out a continuing, cooperative, and comprehensive transportation planning process; Section 174 of the Clean Air Act designates this same organization as responsible for the transportation-related air quality planning within designated nonattainment and maintenance areas to achieve and maintain NAAQS; and

WHEREAS, the EPA has designated three nonattainment areas in the SPC planning region for the 8-Hour Ozone NAAQS; these include the Pittsburgh-Beaver Valley nonattainment area (comprised of the seven counties: Allegheny, Armstrong, Beaver, Butler, Fayette, Washington, and Westmoreland); the Greene County nonattainment area; and the Clearfield-Indiana nonattainment area (comprised of Clearfield County, which is outside of SPC's planning area, and Indiana County which is within SPC's planning area); and

WHEREAS, the EPA has designated three nonattainment areas in the SPC planning region for the PM 2.5 NAAQS; these include the Liberty-Clairton nonattainment area (comprised of five municipalities within Allegheny County); the Pittsburgh-Beaver Valley nonattainment area (comprised of Beaver, Butler, Washington, and Westmoreland counties in their entirety and portions of Allegheny, Armstrong, Greene, and Lawrence counties); and the Johnstown

nonattainment area (comprised of portions of Indiana County within SPC's planning area, and all of Cambria County which is in the planning area of the Johnstown MPO); and

WHEREAS, the EPA has designated a maintenance area in the SPC planning region for the PM 10 NAAQS consisting of five municipalities within Allegheny County; and

WHEREAS, the EPA has designated a maintenance area in the SPC planning region for the Carbon Monoxide (CO) NAAQS consisting of the City of Pittsburgh's central business district; and

WHEREAS, the EPA, in the Transportation Conformity Rule (40 CFR Part 93), as amended, provides criteria and procedures to be followed by Metropolitan Planning Organizations (MPOs) in making conformity determinations regarding transportation plans, programs, and projects within designated nonattainment and maintenance areas; and

WHEREAS, the Transportation Conformity Rule and Sections 174 and 176(c) and (d) of the Clean Air Act (Sections 7504 and 7506(c) and (d) of Title 42 U.S.C.) require that the MPO not approve or amend any plan, program, or project which does not conform with the Clean Air Act; and

WHEREAS, the Transportation Conformity Rule identifies projects and project types which are "exempt" from regional conformity analysis; and

WHEREAS, the Transportation Conformity Rule requires a new finding of conformity by the MPO prior to an MPO action to adopt or amend the Transportation Plan or TIP when that action involves projects or project types which are not "exempt" from regional conformity analysis, or prior to any federal action to approve project designs, environmental documents, or other aspects of "non-exempt" projects that are not required to be programmed on the regional Plan or TIP; and

WHEREAS, the City of Pittsburgh's Sports and Exhibition Authority has proposed "non-exempt" amendments to the TIP and the 2035 Plan; and

WHEREAS, SPC has conducted a qualitative and quantitative analysis for the designated PM 2.5, PM 10, CO, and 8-Hour Ozone nonattainment and maintenance areas within the SPC region in accordance with the applicable criteria and procedures of the Clean Air Act (as amended) and the Transportation Conformity Rule, and has demonstrated that the amended 2035 Plan and 2009-2012 TIP conform with the Clean Air Act; and

WHEREAS, the proposed amendments and the results of the conformity analysis were made available for public review and comment consistent with SPC's established public review procedures from December 17, 2008 through January 21, 2009 including a public meeting held on January 13; and

WHEREAS, documentation of the public review and comment period, public comments received on the conformity analysis and the proposed Plan and TIP amendments, and responses to comments have been compiled and presented to the Commission.

NOW, THEREFORE, BE IT RESOLVED that the Southwestern Pennsylvania Commission finds that the region's amended 2035 Plan and 2009-2012 TIP conform to the Clean Air Act (as amended) by supporting its intention of achieving and maintaining the NAAQS; and

BE IT FURTHER RESOLVED that the region's amended 2035 Plan and 2009-2012 TIP are consistent with the Clean Air Act (as amended) and the Transportation Conformity Rule; no goals, directives, recommendations, or projects in the Plan or TIP contradict in a negative manner any specific requirements or commitments of applicable State Implementation Plans (SIPs).

RESOLVED FURTHER that assessment of the designated PM 2.5, PM 10, CO, and 8-Hour Ozone nonattainment areas within the SPC region demonstrates that the amended transportation plans, programs, and projects for those areas conform with the provisions of the Clean Air Act and the applicable criteria and procedures of the Transportation Conformity Rule.

AND

WHEREAS, Federal transportation law (Section 134 of Title 23 U.S.C. and Section 5303 of Title 49 U.S.C.) and metropolitan transportation planning regulations (Part 450.220 of Title 23 C.F.R.) continue the requirements established in earlier legislation that Metropolitan Planning Organizations (MPOs) conduct a comprehensive transportation planning process and develop and maintain a Long-Range Transportation Plan and Transportation Improvement Program that conform with various Federal requirements; and

WHEREAS, the City of Pittsburgh's Sports and Exhibition Authority has proposed the following revisions to the TIP and the 2035 Plan:

- Move funding for the Brighton Road Extension project (a new road connecting West General Robinson Street and North Shore Drive) from Stage Two of the 2035 Plan to Stage One of the 2035 Plan (thereby adding the project to the 2009-2012 TIP for funding in FY 2009) at a total cost of \$1,800,000 (\$730,078 federal SAFETEA-LU earmark; \$1,069,922 non-federal funds committed by the Sports and Exhibition Authority); and

WHEREAS, the proposed TIP and Plan amendments will maintain overall Plan and TIP fiscal balance and will not interfere with the implementation of any projects, commitments, or requirements of applicable State Implementation Plans (SIPs); and

WHEREAS, SPC has conducted qualitative and quantitative analysis consistent with the applicable criteria and procedures of the Clean Air Act (as amended) and the Transportation Conformity Rule, and has demonstrated that the amended 2035 Plan and 2009-2012 TIP conform with the Clean Air Act; and

WHEREAS, the proposed amendments and the results of the conformity analysis were made available for public review and comment consistent with SPC's established public review procedures from December 17, 2008 through January 21, 2009 including a public meeting held on January 13; and

WHEREAS, documentation of the public review and comment period, public comments received on the conformity analysis and the proposed Plan and TIP amendments, and responses to comments have been compiled and presented to the Commission; and

WHEREAS, the proposed amendments have been reviewed by the Transportation Technical Committee and recommended for approval in accordance with SPC's approved Plan and TIP amendment policies.

WHEREAS, the finding of conformity with the Clean Air Act for the amended TIP and 2035 Plan is made in SPC Resolution 1-09.

NOW, THEREFORE, BE IT RESOLVED that the Southwestern Pennsylvania Commission approves the request made by the City of Pittsburgh's Sports and Exhibition Authority to amend the 2035 Plan and the 2009-2012 TIP.

Mayor Eisaman seconded and the affirmative vote to approve Resolutions 1-09 and 2-09 was unanimous.

5. Action on Resolution 3-09 to Approve Submission of the 2009-2010 Unified Planning Work Program to the Funding Agencies

Mr. DiPietro reported that this is the time of the year we submit our work program to PennDOT which outlines our transportation planning tasks for consideration for state and federal funding for the next fiscal year starting July 1. Today's request is to approve submission of the 2009-2010 Unified Planning Work Program to the appropriate state and federal transportation planning funding agencies.

Mr. DiPietro said that annually SPC receives guidance for developing the UPWP from state and federal funding sources: Original federal transportation legislation (SAFETEA-LU); Annual FTA/FHWA guidance; and Annual PennDOT guidance. Typically this occurs in September, but it did not arrive until January 7 this year.

Mr. DiPietro said that proposed funding levels include federal, state, SPC match and other local entities match. He then explained the following program areas and their level of funding:

Mr. DiPietro added that action today to submit the UPWP funding request will ensure funding approvals are in place before the start of the fiscal year. We will be back in June with the status of this program and with the other parts of the overall SPC budget including operation of the Regional Enterprise Tower and the economic development programs.

Mr. Miller asked how today's UPWP action relates to the advancement of Project Region? Mr. Miller added that Project Region is a Plan that needs to have its own accountability towards what we are doing to implement it. Project Region represents our expectations as a region and we should continue to use it as a way to set what it is that has been started. Mr. DiPietro noted that Project Region was the process used to develop the 2035 Transportation and Development Plan that was adopted in June of 2007 and the 2009-2010 UPWP continues to advance implementation of the 2035 Plan developed from Project Region on multiple fronts, and will also initiate the process for the next Plan update due by June 2011.

Mr. Piper commented that SPC is doing an excellent job in advancing the Regional Signal Program Initiative. Advancing corridor coordinated signal improvements is low cost and money well spent.

Mr. Silvestri moved:

WHEREAS, the 2009-2010 Unified Planning Work Program documents all transportation and transportation-related planning activities to be undertaken within the SPC region from July 1, 2009 through June 30, 2010; and

WHEREAS, the 2009-2010 Unified Planning Work Program identifies planning tasks to be performed by SPC staff and the staffs of the member Counties, the City of Pittsburgh, and the Port Authority of Allegheny County using planning assistance funding from the Federal Highway Administrative, the Federal Transit Administration, and the Pennsylvania Department of Transportation.

NOW, THEREFORE, BE IT RESOLVED, that the Southwestern Pennsylvania Commission approves submission of the 2009-2010 Unified Planning Work Program; and

BE IT FURTHER RESOLVED, that the Executive Director, on behalf of SPC, is hereby authorized to enter into Agreements and/or Supplements with the Federal Transit Administration of the U. S. Department of Transportation, and the Pennsylvania Department of Transportation relating to the 2009-2010 Unified Planning Work Program and pursuant to application requests.

Commissioner Scahill seconded and the affirmative vote to approve Resolution 3-09 was unanimous.

Dr. Hassinger confirmed SPC's Annual Retreat would be held on February 19th and 20th in Farmington, PA. The agenda will be mainly about the current status of the stimulus legislation and related priorities for the region.

Regional Integrated Water Planning – Mr. Villotti provided an update on the Regional Integrated Water Planning Initiative. As was reported at the November Commission meeting, the Executive Committee met in November and passed a resolution that stated the Southwestern Pennsylvania Commission acknowledges and endorses the recommendations set forth in the report of the Regional Policy Advisory Committee in the matter of the Regional Water Management Task Force Recommendation and directs staff to take the steps necessary to implement the recommendations as outlined in the Regional Policy Advisory Committee report. SPC will put water resource planning on a level with transportation and economic development planning.

Mr. Villotti said also included in the resolution and in the report was a discussion of the 24-month initial starter kit strategy with an approximate cost of about \$2.7M. He stated that the initial local source of funding would be program specific dues for member jurisdictions not to be expended until such time as funding for the starter kit strategy has been secured. He stated that to date staff has met with representatives of the philanthropic community, the Benedum Worthington Foundation and the R.K. Mellon Foundation who had previously expressed an interest in participating in this endeavor. In addition, staff has also met with Senator Casey staff and Senator Specter staff.

Mr. Villotti reiterated that program specific dues would not be administered until such time as funding from the starter kit strategy is in place.

RESOLUTION NO. 6-09

A RESOLUTION OF THE SOUTHWESTERN PENNSYLVANIA COMMISSION to amend the region's 2009-2012 Transportation Improvement Program (TIP) to include transportation projects to be advanced with American Recovery and Reinvestment Act of 2009 funding.

WHEREAS, PENNDOT District 11-0 and 12-0 request the following amendments to the Title I Component (Surface Transportation Program) of the region's 2009-2012 Transportation Improvement Program (TIP) to be advanced with American Recovery and Reinvestment Act of 2009 highway and bridge funding:

1. Route 28 Widening Preparation and Railroad Relocation - \$45,956,000 Federal for construction in FFY 2009. This project includes work to prepare the area along Route 28 for the East Ohio Street improvement project and includes relocating railroad tracks, and other work needed to begin the larger improvement project. The Route 28 Widening Project extends from Troy Hill in the City of Pittsburgh north to the 40th Street Bridge at Millvale in Allegheny County.
2. Route 51 Beaver-Rochester Bridge Rehabilitation - \$20,000,000 Federal for construction in FFY 2009. The project is located in Rochester and Bridgewater Borough over the Beaver River in Beaver County.
3. I-79 CPR (concrete patching & repair) - \$16,000,000 Federal for construction in FFY 2009. The project extends on Interstate 79 from the interchange of Interstate 79 and SR 980 near Canonsburg north to the Allegheny County line in Washington County.

WHEREAS, The Butler Transit Authority (BTA), the Mid-Mon Valley Transit Authority (MMVTA), the New Castle Area Transit Authority (NCATA), the Port Authority of Allegheny County (PAAC) and the Westmoreland County Transit Authority (WCTA) request the following amendments to the Title III Component (Public Transportation) of the region's 2009-2012 Transportation Improvement Program (TIP) to be advanced with American Recovery and Reinvestment Act of 2009 transit funding:

1. BTA: Butler Multi-Modal Center – Pullman Redevelopment Area – (\$5,000,000 Federal) for construction of the administrative and bus storage facility portions of this project located in Butler's Pullman Redevelopment Area.
2. MMVTA: Donora Intermodal Transit Facility – Phase I – (\$3,545,171 Federal) for renovation and construction of an intermodal transit facility located on 3.5 acre site in the Borough of Donora, Washington County.
3. NCATA: Facility Roof Replacement - (\$2,900,000 Federal) for removal of entire existing roof due to severe structural deficiencies and subsequent replacement of roof structure.
4. PAAC: Infrastructure Renewal and Repair (North Shore Connector) - (\$117,800,000 Federal) for completion of 1.2 mile extension of PAAC light rail system from its terminus at Gateway Station

in Downtown Pittsburgh to serve the North Shore/North Side area of Pittsburgh.

5. PAAC: Hybrid Buses – (\$10,000,000 Federal) for procurement of 20 hybrid engine-powered buses.
6. PAAC: East Busway Pavement Replacement – (\$27,870,000 Federal) for replacement of 16.8 lane miles of full-depth concrete pavement, grade adjustments and reconstruction of inlets for the 25-year old East Busway.
7. PAAC: Warrington Track & Pavement Replacement – (\$13,000,000 Federal) for replacement of embedded track along Warrington Avenue from Haberman Avenue to Arlington Avenue – approximately one half mile.
8. PAAC: Mt. Lebanon Rail Tunnel Replacement – (\$9,000,000 Federal) for replacement of approximately 5,800 feet of rail within PAAC’s Mt. Lebanon Light Rail Transit Tunnel. Also, drainage improvements and upgrades to the emergency ventilation systems.
9. WCTA: Maintenance Facility Improvements – (\$2,415,000 Federal) funds to be added to this project to complete both phase one and phase two improvements described in the WCTA Maintenance Facility Master Development Plan.
10. WCTA: Environmental Assessment and Preliminary Engineering for Commuter Rail Service – (\$6,000,000 Federal) for completion of federally-required planning and engineering tasks associated with the first phase of a proposed federally-funded commuter rail line linking Westmoreland and Allegheny Counties.

WHEREAS, the sources of funds for the proposed TIP amendments are from the American Recovery and Reinvestment Act of 2009 and therefore are additional funds to the region; and

WHEREAS, the proposed TIP amendments will maintain overall TIP fiscal balance and will not interfere with the implementation of any projects, commitments, or requirements of applicable State Implementation Plans (SIPs); and

WHEREAS, approval of the proposed amendments to the 2009-2012 TIP will not alter the finding of conformity with the federal Clean Air Act for the 2035 Long Range Plan and 2009-2012 TIP since the affected projects are categorized by EPA's Transportation Conformity Rule (40 CFR Part 93) as being exempt from regional emissions analysis; and

WHEREAS, the proposed amendments were made available for public review and comment consistent with SPC’s established public review procedures from February 27th continuing through March 27th , including four public meetings held on March 2nd, March 3rd, March 4th, and March 9th; and

WHEREAS, documentation of the public review and comment period, including public comments received to date on the TIP amendments and responses to comments to date have been compiled and presented to the Commission; and

WHEREAS, the proposed amendments have been reviewed on February 27th at separate meetings of the Transportation Technical Committee and the Transit Operators Committee and are recommended for approval in accordance with SPC's approved TIP amendment procedures.

NOW, THEREFORE, BE IT RESOLVED that the Southwestern Pennsylvania Commission approves these amendments to the 2009-2012 TIP and that this action is effective immediately for all projects listed with funding amounts less than or equal to \$10,000,000, and

BE IT FURTHER RESOLVED, that this action is effective for all projects listed with funding amounts in excess of \$10,000,000 as of the close of the public comment period on March 27th, with any additional comments received through March 27th to be shared expeditiously with the full Commission membership, including responses to any additional comments.

RESOLVED FURTHER that many SPC member jurisdictions' high priority projects could not be included in the current TIP because of significant funding constraints at adoption last June; and

RESOLVED FURTHER that additional ARRA funding to the region is expected to advance ready-to-go projects, many on the current TIP, which is expected to free up some level of funding that may thus be available for additional programming; and

RESOLVED FURTHER that the Commission now expresses its preference that projects of a high priority in member jurisdiction plans be given a high priority for inclusion on the TIP in accordance with SPC adopted TIP amendment procedures to replace projects as they are advanced through ARRA funding; and

RESOLVED FURTHER that the Commission expresses its preference that inclusion of such member jurisdiction projects, once determined eligible and described appropriately for inclusion on the TIP in accordance with SPC adopted TIP amendment procedures, be given a high priority for inclusion to replace projects that have been moved up for implementation with ARRA funding.

RESOLUTION NO. 7-09

A RESOLUTION OF THE SOUTHWESTERN PENNSYLVANIA COMMISSION (SPC), at the request of the Pennsylvania Department of Transportation (PennDOT) to enter into a new five-year Open-End Base Agreement (Agreement) covering future transportation planning activities performed by the SPC. The five-year Base Agreement is a change in PennDOT's contracting process for the Unified Planning Work Program (UPWP), whereby a planning agency's required UPWP becomes a Work Order within an overall Base Agreement.

WHEREAS, the Base Agreement will commence on July 1, 2009 and have a completion date of June 30, 2014, with an option to extend by letter amendment for single or multi-year extensions. However, in no event shall the Agreement continue past June 30, 2019; and

WHEREAS, the total cost, pursuant to the Base Agreement, shall not exceed Twenty-Five million dollars (\$25,000,000) for the original five-year term unless amended by letter amendment; and

WHEREAS, once the new Base Agreement is in place, the Commonwealth/PennDOT process to review and approve UPWPs and supplemental agreements will allow for a significant reduction in the time needed to grant a notice to proceed; and

WHEREAS, the SPC is the designated entity, pursuant to federal regulations, responsible for the developing and carrying out the transportation planning process specified in Title 23 and/or Title 49 of the United States Code for the area within its jurisdiction; and

WHEREAS, SPC approved the submission of the 2009-2010 Unified Planning Work Program (July 1, 2009 through June 30, 2010) to the appropriate funding agencies on January 26, 2009 through SPC Resolution 3-09. Upon approval by the funding agencies, the identified planning work program will be incorporated as Exhibit A – Scope of Work under the new Base Agreement; and

NOW, THEREFORE, BE IT RESOLVED, that the Southwestern Pennsylvania Commission approves entering into a five-year Open-End Base Agreement (Agreement) with the Commonwealth of Pennsylvania Department of Transportation (PennDOT) commencing July 1, 2009 for work performed by the SPC in accordance with the approved Planning Partner Open-End Unified Planning Work Program (UPWP) contract scope of work.

BE IT FURTHER RESOLVED, that the Executive Director, on behalf of SPC, is hereby authorized to enter into Agreements, as well as the Work Orders generated from the Agreement, and/or Supplements with the U. S. Department of Transportation Federal Transit Administration, other federal agencies as needed, and the Commonwealth of Pennsylvania Department of Transportation relating to said Agreement pursuant to application requests.
